Community officials who are authorized by local law or ordinance to provide floodplain management information, may also sign the certification. In the case of Zones AO and A (without a FEMA or community issued BFE), a building official, a property owner, or an owner's representative may also sign the certification.



COMMENTS:

Pima County Floodplain and Erosion Hazard Management Ordinance 1994-FC2 in Article XI requires the bottom of the structural frame of a manufactured home to be a minimum of one foot above the base flood elevation. For "A" or "AO" Zones Pima County requires the manufactured home floor reference level to be a minimum of one and one half feet above the bottom of the structural frame elevation which equals two and one half feet above the base flood elevation as listed in item 6 of Section B of this form. This elevation certificate is to be certified in Sections C and E. A copy is to be returned within seven days of placement of the manufactured home, to Pima County Floodplain Management Section, 201 N. Stone Ave., 4th Floor, Tucson, AZ 85701. Phone 740-6350.



The diagrams above illustrate the points at which the elevations should be measured in A Zones and V Zones. Elevations for all A Zones should be measured at the top of the reference level floor. Elevations for all V Zones should be measured at the bottom of the lowest horizontal structural member.
